The following document set forth the Privacy Policy for the Better Storage Systems website, *www.betterstorage.com.au.*

BSS respects the privacy of individuals by treating all personal information as confidential and by handling it in accordance with the Privacy Act 1988 and the National Privacy Principles. During the course of its activities, BSS will collect, use and disclose personal information from:

- Customers who visit or use any of our Internet services;

1. Collection and use of personal data and information

BSS may use cookies to collect information from you. Cookies identify a particular computer to BSS's server. BSS may use the information collected in this way to provide the user of that computer with a personalised experience of BSS's website. Your browser may allow you to disable cookies. If you do this, your experience of the BSS website will not be personalised.
