

1. Warranty

SSI SCHAEFER offers a 2 year warranty for its static industrial storage equipment which covers the structural integrity of the product and any defects in materials or workmanship, subject to the

The defects liability period starts upon practical completion or beneficial use of the system by the customer, whichever is the sooner, but at the latest 30 days after readiness for practical completion testing

The defects liability does not include defects caused by the customer or third parties, for instance due to inadequate use, inadequately performed repairs or modifications without previous written consent by SSI SCHAEFER or defects caused by external influences. Normal wear and tear is not considered a defect and thus not covered by any liability; in particular, components subject to wear and tear are excluded from the liability for defects.

STRUCTURAL INTERGRITY
SSI SCHAEFER will repair or replace at no-charge to the client any component that fails to meet the original design specification, subject to the following conditions:

- This warranty does not cover components which are subject to loadings over and above those stated in SSI SCHAEFER's offer or any component subjected to damage or misuse
- SSI SCHAEFER is advised immediately that any damage to the product occurs and is given full access to site to assess such damage. The definition of structural damage includes the cracking, deformation or collapse of the product during the course of the warehouse operation.
- All users are fully aware of the design capacities of the product.



DEFECTIVE MATERIALS & WORKMANSHIP
SSI SCHAEFER will replace or repair at no cost to the client all parts, which in SSI SCHAEFER's ion have deteriorated due to defects in manufacture, mate following conditions:

- The product is inspected by SSI SCHAEFER or its authorised distributor every twelve (12) months after installation for the entire warranty period at an agreed fee
- 2. Parts which have deteriorated due to fair wear and tear or have been subjected to accidental damage are immediately replaced at the client's expense
- Any equipment subjected to user damage is unloaded and SSI SCHAEFER is immediately informed. Failure to have the damage repaired invalidates the warranty. SSI SCHAEFER is informed of any changes made to the product design, including aisle
- length, additional beam levels or changes to beam levels

This warranty is only applicable to new SSI SCHAEFER components installed and maintained by SSI SCHAEFER or its authorised distributors.


Safety Management
